WHEREAS, applications were invited from eligible candidates for hiring of *Cluster Resource Coordinators for teaching support in Government High and Higher Secondary Schools of Kashmir Division* for the Academic Session 2023-24 (31<sup>st</sup> March 2024) , vide Notification No. 01-DSEK of 2023 Dated: 09-08-2023; and

WHEREAS, the applications received from the candidates were scrutinized and District-wise, subject-wise merit lists were published for the information of concerned individuals and for inviting objections, if any; and

WHEREAS, accordingly the objections so received were scrutinized and considered on merits ; and

WHEREAS, after scrutiny of the documents (uploaded by the candidates) by the committee of officers headed by Joint Director (Central & North) & Joint Director (South), a redrawn merit list of candidates was issued for information of all concerned.

Now therefore, the candidates in the disciplines of **Environmental Science** shown in the **Annexure** to this order are hereby hired temporarily on need basis as *Cluster Resource Coordinators* in the institutions as mentioned against each:

The date of joining shall be considered as per joining report of the candidate duly endorsed by the concerned Principal. The Hiring of need basis Cluster Resource Coordinator is purely on temporary basis and subject to the following terms and conditions. The Principal concerned shall strictly ensure the fulfillment of below mentioned conditions in letter and spirit.

Terms and Conditions:

1. Submission of an affidavit duly attested by the Judicial Magistrate First Class as per prescribed format.
2. Satisfactory Character and Antecedents Report from CID.
3. Verification of the following documents in terms of their authenticity and genuineness:
  - a) Domicile Certificate.
  - b) Degree/Marks Certificate.
  - c) NET/SLET Certificate, if any.
  - d) M.Phil/Ph.D Degree Certificate, if any.
  - e) Publications; if any.
4. The selected candidate should not be working on temporary/permanent basis (Online/Offline) in any Government/Semi-Government Department in Jammu/Kashmir Division or anywhere else in the country and neither is in receipt of any scholarship or any other type of financial support leading to the award of any degree/diploma, etc. Furthermore, the candidate is not engaged on academic arrangement anywhere else.
5. The candidates should join within a period of 05 days, failing which next candidate in order of merit shall be considered for hiring.
6. In the event of any errors/mistakes in the calculation of merit/points based on the criteria, the hiring shall be subject to cancellation without any notice to the candidates.
7. The Government reserves the right to de-hire the services of any candidate without any notice.
