07. Proper books of accounts of the expenditure incurred out of the grant shall be maintained as per the prescribed norms.
08. The Accounts and other records shall be open to audit and inspection by the society.
09. Further, funds shall be released only after receipt of utilization certificate along with the copy of monthly pay acquaintance rolls of each institution to this office before 10<sup>th</sup> of every month.
