Pursuant to the State Project Director, RMSA Jammu and Kashmir, Srinagar's order under reference, sanction is hereby accorded to the release of funds to the tune of Rs. 11,25,000= Rupees Eleven lacs twenty five thousand only in favour of Heads of the Hr. Sec./High Schools as per details envisaged in Annexure "A" on account of "SELF DEFENSE / MARTIAL ART TRAINING OF GIRL STUDENTS AT SECONDARY LEVEL" approved by PAB under integrated AWP&B 2017-18 under RMSA.

In addition to, the following explicit conditions shall be adhered to in true letter and Spirit.

01. The activity is time bound and is to be completed in the stipulated time during the current Fiscal year vis-a-vis 31-03-2018.
02. The Target group of girl students is class 9th, 10th, 11th and 12th.
03. Attendance of the identified girl students with their photographs and record of achievement thereof has to be maintained and communicated to this office for onward submission to DRMSA.
04. Before utilizing the funds, the DDO concerned shall prepare a detailed Action Taken Plan for effective implementation of the activity with a copy to this office for perusal / examination.
05. The funds shall be utilized strictly as per RMSA guidelines and any deviation, shall be the personal responsibility of the Principal/ Headmaster/ Care taker of the school.
06. No re-appropriation of funds in any case is allowed.
07. Utilization certificate along with Red Account, Expenditure statement, Photo album and Videos in a CD and other related documents be submitted to this office within 15 days after the completion of activity.
08. The admissible payments should be made through E-transfer, Cross / Payees a/c cheques and no transactions shall be made in cash.
09. Separate and Proper book of accounts of the expenditure incurred out of the grants shall be maintained strictly as per the Financial rules and norms in vogue.
10. There should be no duplication of funds for the same purpose or activity from any other source/ scheme.
11. The name-wise list of students oriented through this activity should reach this office duly signed by the SMDC members within 15 days after the completion of the activity.
12. The accounts and other records shall be open to audit and inspection by the Society and Chartered Account and the grants received / utilized under RMSA must be displayed on the board with access to all the visitors.
