Pursuant to the State Project Director, RMSA Jammu and Kashmir, Srinagar's order under reference, sanction is hereby accorded to the release of funds to the tune of **Rs. 1,75,000= Rupees one lac seventy five thousand only** in favour of **Heads of the Hr. Sec. Schools and Principal/Head of DIET Beerwah** as per details envisaged in Annexure "A" on account of **"Herbal Garden" @ Rs. 0.05 per school** under RMSA Plan 2017-18. **In addition to, the following explicit conditions shall be adhered to in true letter and Spirit.**

1. The activity is time bound and is to be completed in the stipulated time during the current Fiscal year viz-a-viz **31-03-2018**.
2. **The funds should be incurred strictly on the components as per norms of RMSA detailed in the guidelines and as per the need and requirement of each school, within the prescribed components assessed/ prioritized by SMDC's.**
3. The funds shall be utilized through SMDC's and any deviation, shall be the personal responsibility of the Principal/ Headmaster/ Care taker of the school.
4. No re-appropriation of funds in any case is allowed.
5. Utilization certificate along with Red Account, Expenditure statement and other related documents be submitted to this office within 15 days after the completion of activity.
6. **The admissible payments should be made through E-transfer, Cross / Payees a/c cheques and no transactions shall be made in cash.**
7. Separate and Proper book of accounts of the expenditure incurred out of the grants shall be maintained strictly as per the Financial rules and norms in vogue.
8. **The Expenditure on account of organizing meeting of SMDC should not exceed Rs. 1000 (Rupees one thousand only).**
9. **There should be no duplication of funds for the same purpose or activity from any other source/ scheme.**
10. The accounts and other records shall be open to audit and inspection by the Society and Chartered Account.




